Ithaka's goal is to provide permanent affordable rental units targeting individuals who earn less than 30% of the area median income.

In addition to permanent affordable housing, Ithaka operates two hospitality houses with twenty-three beds for no or low income people in transition. These houses take in people who are often not eligible for other housing programs - applicants need not have any income for acceptance.
